The franchisee will engage in the opening and operation of a fitness and weight loss studio under the Contours Express® trademark and system of operating procedures. The franchisee will operate the business from an approved location, which is customarily located within the confines of a retail strip center or freestanding building.

The initial franchise fee for individual unit franchises is \$18,000.00. We may offer an option to purchase a second unit for an initial franchise fee of \$12,000. See Item 5. The estimated initial investment required for individual unit franchises ranges from \$55,720.00 to \$95,420.00. See Item 7

RISK FACTORS:

- 1. THE FRANCHISE AGREEMENT PROVIDES THAT THE FRANCHISOR HAS THE RIGHT TO SUE FRANCHISEE IN KENTUCKY FOR SUMS DUE IT, FOR MATTERS AFFECTING ITS RIGHTS RELATING TO ITS TRADEMARKS AND CONFIDENTIAL INFORMATION, AND FOR PRELIMINARY INJUNCTIVE RELIEF.
